With their assets and building they opened the possibility for a new Mission Development ministry to replace what had once been. Pastor Jessica Olson-Miller began The Neighborhood Church primarily as a food bank and feeding ministry for the North Fargo area, and it has been going strong for 5 years. They host pop up food pantries in their parking lot every Wednesday which are a great opportunity for volunteers to serve and connect with the local community. Recently they have gained a stable congregation and have been able to offer worship experiences and youth programming. Today our noisy offering will go to support Pastor Jessica and her ongoing efforts. The Neighborhood Church is an example of our God that brings new life out of death, and the wonderful things that can happen when we listen to what The Holy Spirit Calls us to.

From Vicar Steve

On February 19th, we took a group of young people to Red River High School in Grand Forks for what we called ELCA Youth Night. It was a great evening! My guess is the kids liked our trip to Pizza Ranch the most, but I hope they got something out of the overall experience. We were fortunate to have former UND football coach Bubba Schweigert on hand to speak to the kids about what being a person of faith looks like, while also being a very public figure. He talked about how his job was to be a football coach, but his vocation was to help lead young men.

We also heard from Deacon Erin Power who heads up action and advocacy for the Eastern ND Synod. One of the things our kids learn at events like this is that they are part of a larger church. I do think it helps them to see about 300 other kids in the room who all go to confirmation class and attend churches just like theirs. Deacon Erin talked about the structure of the Synod, and how she also lives her vocation as an advocate for people who struggle in this state. Deacon Erin works with organizations who rely on state and federal funding to operate, doing things like providing food and shelter for the homeless, providing safe places for underserved groups of people, and working with ministers like me to be more attentive to minority groups we may be serving in our calls.

The message we were trying to convey to our young people is that you may be good at a certain thing, and you may have a job that uses those skills, but what you do is much deeper. Think about your job. Maybe you're a mechanic, maybe you do data entry, maybe you run a register at a store. You may at times wonder if people even care about what you do or if it's even worth it. In some way whether you know it or not, you help others. The grocery store can't operate unless they have someone at the checkout, if the grocery store can't run properly, the people don't have a stable place to go where they can buy food. Maybe you enter data on spreadsheets all day. The data you manage helps an entire operation function properly so they can provide goods and services to people who need them. Young people need to hear these kinds of things more. God works through everything we do, no matter what we do, to serve our communities and the people in them. We don't have to be the greatest or the best, we just need to be ourselves and let God use our gifts and talents to whatever end they may best help people. Martin Luther once said, "God milks the cows through whoever's vocation that is." Take pride and joy in what you do, because you are needed in this world, and you play an important part. Tell the people you love that they are also needed, and what they do matters. Especially, tell your kids that you are proud of them no matter what they choose to do in the future. God has great futures for all of them, and they are sum of the best parts of all of us. Amen.

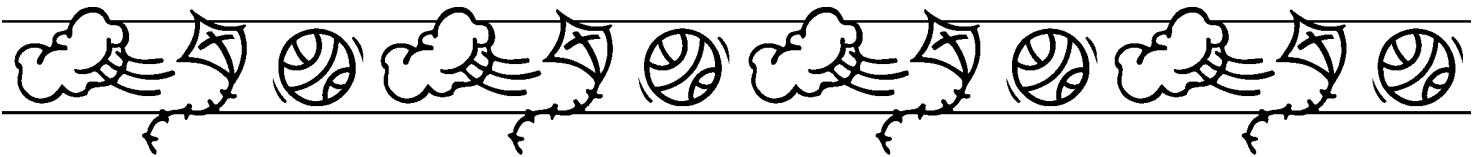
